Indianola Beach Improvement Club (IBIC) Boat Storage Rack Rules

The number one objective for these rules is to keep the boat rack and Rose Marie's Park neat, maintainable, safe and usable for their intended purposes.

Boat Registration

All Boat Rack users must be Members of IBIC.

Registration Fee - \$30.00 / Year and payable at time of space assignment.

All boat owners shall have an IBIC Registration Sticker, their name and phone number on the hull of their boat for identification before being placed on the boat rack. Boats must be placed on the boat rack with the registration sticker and ID information showing.

Boat Limit: 1 vessel allowed on boat rack per membership unless space is available.

Restrictions on Location of Boat Storage

Vessels shall be stored only on the boat rack, not on the grass or logs of Rose Marie's Park. Paddle boards not allowed.

Owner's Responsibilities - Insure, Secure Your Boat / Restrictions

It is the sole responsibility of the boat owner to insure their boat and to lock up their boat while being stored on the boat rack. Leave paddles and other personal items in the park at owner's risk. IBIC shall not be held liable for any theft or damage done to any boat while at Rose Marie's Park.

Boat engines shall not be left unattended in the park. Additionally, any containers with flammable liquids of any amount shall not be left unattended in any area of Rose Marie's Park and shall be immediately removed by IBIC without notice to owner.

Boats shall be kept in good repair and usable.

Boat Size and Type Limitations

Kayaks and canoes shall be no longer than 20 feet and no heavier than 100 lbs.

Rowboats shall be no longer than 12 feet and no heavier than 200 lbs.

Only Inflatable boats with hard hulls allowed (ex: fiberglass or wood hull). All other inflatables, including multi-person rafts, not allowed.

Assigning Your Boat to a Space / Placement Lottery / Removal of Boats

A new assignment list for placement of boats shall be generated annually. If there are more owners requesting spaces on the boat rack than there are total spaces, the IBIC shall hold an annual lottery drawing to determine who will be allowed to use the boat rack. Those who are not assigned a space will be put on a wait list. They will also be automatically placed at the top of the next year's assignment list. The lottery will be held every March. (Date will vary). IBIC membership must be current at that time.

If a boat was awarded a space on the boat rack last year but is not picked for placement in the current year, removal shall be required within 20 days of the annual lottery assignment date. For extenuating circumstances, contact the IBIC.

Regardless of the situation, the IBIC has the sole authority to assign the location of boats on the boat rack. Narrower boats shall be expected to share a space. Boat owners shall not exchange locations without prior IBIC approval. No subleasing allowed.

Vacated Spaces

Boat rack users shall notify the IBIC if they intend to vacate their spot for the remainder of the year. IBIC has the sole authority to reassign vacated spaces.

New Rules

The IBIC reserves the right to make new rules or modify current rules as the need arises. Boat rack users will be given ample notification of any new or changed rules. New rules will also appear in the *Indianola Breeze*.

Keeping Contact Information Current

Registrants shall notify the IBIC of contact information or ownership changes. The inability of the IBIC to contact the owner may result in non-notification of the annual lottery date (if necessary), rule changes, notification of removal for rack repairs, and the inability to return your boat if it becomes lost, stolen or derelict.

Removal of Boats in Non-compliance of IBIC Rules

The IBIC shall follow the laws and procedures of Kitsap County and the State of Washington in the removal of those boats that qualify as non-compliant. Effort will be made to contact the owner first as required by law.

Report Problems or Thefts

The IBIC requests that boat rack users report any blatant violations of these rules, any damage to the boat rack, and any thefts of boats or personal property. Also, it is the responsibility of boat owners to report the theft of their boat to the Kitsap County Sheriffs Department.

Additional Boat Storage Rack Rules, Deadlines

Adopted June 8, 2017

Deadline to Receive IBIC Membership Form/Dues, and Vessel Registration Form

IBIC Membership Form, with dues, and Vessel Registration Form must be received by 6:00 PM March 7. Reason: This will allow the IBIC to know before the annual assignment meeting if a lottery will be necessary. Please note that this is the date forms must be <u>received</u>, not postmarked if mailed. If March 7 is a Sunday, the deadline will extend to March 8.

On-Time and Late Registrant Placement Procedures

The IBIC will keep two registrant lists; those who register on time (Wait List A) and those who register after the March 7 deadline (Wait List B).

On-Time Placement Procedures

Those who register by the March 7 deadline will be placed on the boat rack. However, if a lottery is necessary by that date, these registrants will make up the only lottery list to be drawn from. Those not receiving a place during this lottery will be put on Wait List A in the order their name is drawn during the lottery.

Late Registrant Placement Procedures

Those who join the IBIC and/or register their boat after the March 7 deadline will be assigned a spot according to the order they are received. No lottery will be drawn for late registrants. They will be placed on a late-registrant's wait list (Wait List B) and will be offered a space after Wait List A (if there is one) is used up.

Those who late-register after the March assignment meeting will be added to the bottom of Wait List B in the order they are received.

Cutoff Date for Next Year's Assignment List

Those on Wait Lists A and B who were not assigned a spot during the current year will be at the top of the next year's assignment list. The registration cutoff date to qualify for being on next year's assignment list is June 1 of the current year.

Deadline for Payment of \$30 Placement Fee

Deadline to receive the \$30 placement fee is one month (30 days) after the date of the March assignment meeting. If payment isn't <u>received</u> by deadline, they will lose their spot and the next person on the wait list <u>with like vessel</u> will be offered the spot, with their placement fee due within one week.

Date to Open Unassigned, Available Spaces to People with TWO Vessels.

There is a one-boat limit per IBIC membership or household. However, if the boat rack is not full by <u>June 20</u>, a second vessel will be allowed placement. This second vessel must be registered by June 1. It may be registered at the same time the first vessel is registered. An additional \$30 placement fee for this vessel will be due in one week.

Hull Sticker Replacement Fee

For those who lose their hull sticker, a \$5.00 replacement fee for a new hull sticker will be charged.
