A G R E E M E N T  
FOR THE INCORPORATION OF  
INDIANOLA BEACH IMPROVEMENT CLUB

Pursuant to Title XXV, Chapter III, Remington's Compiled Statutes of Washington, and particularly Sections 3872 to 3883 inclusive, being Session Laws of 1895, Chapter 98 and amendatory thereto, the undersigned do hereby associate themselves together for the purpose of organizing a body corporate, under the laws of the State of Washington, as follows:

1.

The undersigned are all citizens and residents of the State of Washington.

2.

The name of this corporation shall be  
INDIANOLA BEACH IMPROVEMENT CLUB.

3.

The purposes for which said corporation is formed are the establishment and maintenance of a library, reading room, and place of social and community meetings, <sup>to</sup> and <sup>to</sup> conduct all community activities as are usually connected with or grow therefrom.

4.

The principal place of business or headquarters of the said corporation shall be in Kitsap County, State of Washington, at Indianola Beach therein, Kitsap Post Office.

5.

There shall be no capital stock, and membership shall be as provided in the By-Laws.

6.

The powers of said corporation shall be:

(a) To hold real and personal estate by ownership, lease, rental, purchase, gift, or otherwise.

(b) To hire, purchase, or erect suitable buildings for its accommodation, to be devoted to the purposes set forth in this agreement.

1.

(c) To receive and hold in trust or otherwise, funds received by gift, dues, bequest, assessments, or otherwise, and to be devoted by it to said purposes.

(d) For said purposes to issue its promissory notes, bonds or other obligations, and secure the same by mortgage on its real estate and other property in such manner as may be provided by its By-Laws.

7.

The affairs of this corporation shall be managed and controlled by a Board of Trustees of not less than three nor more than twenty-five in number, the number of the first and present Board to be nine, which number nine may at any time be increased or thereafter decreased, but within said limitations, in form and manner as shall be provided in the By-Laws.

8.

The first trustees, and who shall serve until the annual meeting to be held August 27, 1927, are:
