Welcome! This is your annual opportunity to show your support for the Indianola Beach Improvement Club. We hope that you will continue your membership in 2023. IBIC membership dues fund the club's maintenance and operation of the five beach access points, the Bud Merrill Pavilion, the Post Office, Rose Marie McClung Park, Gill Park, and the Clubhouse, as well as the club's support of various Indianola community events. Plus, your contributions help sponsor the Indianola Days celebration and other 501(c)(3) activities. Thank you to all who joined the IBIC last year. With the funds generated by dues and additional donations, the club was able to maintain its current properties and activities.

Membership in the IBIC is open to any property owner, resident, or former resident of Indianola. According to the bylaws passed in August 2020, membership for any non-resident requires approval by the Board of Trustees. Be sure to include a description of your connection to Indianola on your membership application so that your eligibility can be accurately determined.

Parking permits continue to be available at an additional charge and only by mail. **(Please enclose a self-addressed stamped envelope)** There is a limit of TWO permits for an Individual Membership and FOUR permits for all other membership categories. Replacement parking permits are \$50 and limited to one per household.
